- o Discussion & Q/A
 - Surprise that the medium age of VOOF is 51yrs; 29% of population over 65 yrs
 - Daytime population is 4600
 - Med home sales price increased by 16%
 - Interest from businesses challenge is affordability of rent, tax & buildout
 - Modest retail gap (leakage)
 - Eating and drinking category is biggest opportunity; taxes are the issue at an overall tax rate of 13.38% (need broader tax base)
 - Class 8, 7 makes a big difference in occupancy rate
 - Businesses should not pay more than 10% of their sales in their occupancy cost
 - Businesses request: more tax rebates for retail & office tax rates
 - Opportunities-building off the hospital; allied health use; restaurant uses on Vollmer
 - Retailer can start more ecommerce returns (will draw more people in) beautification on Vollmer
 - Add rooftops- bring in more younger population
 - Allied uses ex. Physical therapy, dialysis, orthopedic clinics
