Improving the Efficiency of Our Government

Water Billing Made Easier—New Sensus FlexNet Tower Nears Completion

In our ongoing effort to improve efficiencies in governance and the cost-effective delivery of services to our residents, the Village of Olympia Fields is pleased to report that the new Sensus FlexNet Tower is close to completion. The tower, which was approved by the Village's Board of Trustees in January 2022, will improve the Village's water meter reading capabilities. Specifically, the tower will increase accuracy and timeliness in billing and provide residents with a more user-friendly understanding of their water usage patterns. Also with the new tower, the Village will be able to transition to a monthly billing cycle, which will enable residents to identify problems sooner, before they result in costly water bills.

The system's two-way, long-range radio network will be able to read water usage data and provide real-time usage


Ruben Briceno **Maintenance Worker**

The CodeRED emergency notification system is an extremely high-speed telephone communication service that can deliver customized pre-recorded emergency messages directly to homes and businesses via voice, email and text. The service is free to residents and businesses within the Village of Olympia Fields.

We encourage all Village residents and business owners to sign up for CodeRED. It is an indispensable tool for communicating critical emergency information such as natural disasters, criminal activity, power outages, traffic detours and watermain breaks. CodeRED sends alerts about emergency and non-emergency events affecting the Village via telephone, text and email.



information from meters and other sensors located throughout the Village. This will be especially useful in helping the Village's Public Works Department immediately identify high water use issues related to leaks and equipment failure, system outages and other abnormalities that can drive up water costs.



Water Meter Conversion Program



The Village's Department of Public Works is in the final phase of its Water Meter Replacement Program. Through this program, public works representatives will replace old water meters with new state-of-the-art Smart Meters at no cost to residents. With the installation of the upgraded Smart Meters, water meter readings will be conducted remotely via the Sensus FlexNet Tower network, which means public works personnel will no longer need to access your property to do these reads.

We are pleased to report that the majority of Village residences have completed the meter conversion process. If you are one of the 29 residences that have yet to convert to a Smart Meter, please contact the Public Works Department at 708-503-8200 immediately to set up an appointment. Time is of the essence!

Mature Tree Care

According to the International Society for Arboriculture (ISA), caring for mature trees is just as important as planting baby trees. Annual tree inspections can nip budding problems and extend the life of your trees.

Four characteristics of tree vitality:

- New leaf or bud formation
- Leaf size
- Twig growth
- Absence of crown dieback (gradual death of the upper part of the tree)

Tree health and stability are major concerns. Cavity openings, extensive twig dieback and fungal presence (mushrooms) can indicate structural weakness, which could potentially pose a danger to you, your family or your home. Thinning of the tree's crown can also be problematic. For more information, please refer to ISA-arbor.com Mature Tree Care.



To that end, the Village of Olympia Fields, in conjunction with the Beautification Committee, is once again offering the 50/50 Tree Program to residents to help "keep Olympia Fields green." Through this program, the Village splits the cost of a new tree with the resident, thus providing a 50 percent savings on the purchase price of select trees. Residents and Homeowner Associations (HOAs) may purchase up to two trees, while supplies last. Information about the types of trees available and the ordering process will be sent to HOA presidents in September. Interested residents may also obtain information about the 50/50 Tree Program on the Village website at www.olympia-fields.com. Orders must be placed by September 28, for delivery in October. Residents are responsible for planting their own trees. Trees will be available on a first come, first served basis.



Resident News You Can Use

Each month we will answer some of the pressing questions commonly asked by residents. We will also use this space to share special announcements, information and other news you can use.

Fielding Your Questions

Hosting an event in the Village? Planning to build a fence? Want to install an alarm system? Did you know that per the Village's Code of Ordinances, you must obtain a permit to do these things? We are here to help you navigate these and other thorny issues.

Hosting an Event: Anyone planning to host an event in the Village of Olympia Fields, e.g., a parade, concert, festival or other public assembly, must submit an Event Permit Application to the Village at least 30 days in advance of the event. The application is subject to the approval of the Village's Board of Trustees. (Section 18:36–37). The Event Permit Application is available for downloading on the Village's website.

Building a Fence: Anyone planning to build a fence must submit a Fence Permit Application to the Village at least 30 days in advance of fence construction. Fence permit fees start at \$60. The application is subject to the approval of the Village's Board of Trustees. (Section 6:13(a)). The Fence Permit Application and a list of requirements are available for downloading on the Village's website.

Installing an Alarm System: Anyone planning to install an alarm system must submit a Building Permit Application to the Village at least 30 days in advance of installation. The application is subject to the approval of the Village's Board of Trustees. (Section 6:13(a)). Once approved and installed, an Alarm System Registration Form must be filed with the Village along with a \$25 registration fee. The Building Permit Application and the Alarm System Registration Form are available for downloading on the Village's website.

Help for Families with Wandering Family Members

Do you have an elderly or mentally disabled family member who sometimes wanders from home? If you answered "Yes," a Scent Jar may be just what you need. The Olympia Fields Police Department has received a limited shipment of Scent Jars from the Cook County Sheriff's Department. They are available to



Olympia Fields residents on a first come, first served basis—while supplies last.

How They Work

Scent Jars are simple to use. Enclosed in each Scent Jar kit is a cloth and directions for use. Simply open the jar, and remove the cloth. Use the enclosed cloth to thoroughly wipe the armpits of your wandering family member. This will ensure that the cloth absorbs the strongest scent possible of your loved one. It is recommended that you wear rubber gloves when handling the cloth to prevent the possibility of cross contamination with your scent. Once you have used the cloth, place it back in the jar, and close the lid as tightly as possible. Then store the jar (labeled with your loved one's pertinent descriptive information) in your refrigerator. If your family member should wander off, contact the Olympia Fields Police Department immediately, and give them the scent jar; their bloodhound(s) will be able to detect the scent from the cloth, which will aid in locating your lost family member.
